I currently manage the Arizona Department of Water Resources (ADWR), Water Planning Division which includes Colorado River and Tribal liaison duties. I have participated in Hualapai settlement negotiations with the parties that resulted in the Big Sandy River-Planet Ranch Water Rights Settlement Agreement, the Hualapai Tribe Bill Williams River Water Rights Settlement Agreement, and the Bill Williams River Water Rights Settlement Act of 2014. I oversee ADWR staff that sit on the Lower Colorado River Multi-Species Conservation Plan Steering Committee.
