He is responsible for the development and growth of First Solar's pipeline of utility-scale solar energy projects, currently amounting to 2,200 MW in the U.S. and Canada. Mr. De Rosa joined First Solar in July, 2010 through the Company's purchase of NextLight Renewable Power, the largest independent U.S. solar power plant developer. Mr. De Rosa was a founder of NextLight Renewable Power and served as its Chief Executive Officer.

Prior to joining NextLight and First Solar, Mr. De Rosa spent 23 years with Pacific Gas & Electric Company's utility and unregulated affiliates, where he held several senior management renewable energy and energy development positions, including running PG&E's RPS procurement program and the development activities of the Corporation's independent power plant subsidiary. Mr. De Rosa has a long history in the power industry. He is a former Board Member of the Western Electricity Coordinating Council.
