COMMITTEE ACTION

The Committee on Natural Resources met in an open markup session on Wednesday, May 16, 2012, and considered the following bills:

HR 1192, To extend the current royalty rate for soda ash. "Soda Ash Royalty Extension, Job Creation, and Export Enhancement Act of 2011"

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of HR 1192 by unanimous consent.

- An amendment offered by Mr. Lamborn #1 was AGREED TO by voice vote.
- An amendment offered by Mr. Tonko.001 was NOT AGREED TO by a roll call vote of 11 yeas and 24 nays.

Adopted and favorably reported to the House of Representatives, as amended, by a roll call vote of 27 yeas and 10 nays.

HR 3973, To facilitate the development of energy on Indian lands by reducing Federal regulations that impede tribal development of Indian lands, and for other purposes. "*Native American Energy Act*"

The Subcommittee on Energy and Mineral Resources and the Subcommittee on Indian and Alaska Native Affairs was discharged from further consideration of HR 3973 by unanimous consent.

- An amendment offered by Mr. Young of Alaska was AGREED TO by voice vote.
- An amendment in the nature of a substitute offered by Mr. Lujan was NOT AGREED TO by a roll call vote of 13 yeas and 23 nays.
- An amendment offered by Mr. Young of Alaska was AGREED TO by voice vote.

Adopted and favorably reported to the House of Representatives, as amended, by voice vote.

HR 4043, To amend title 10, United States Code, to direct the Secretary of Defense to establish Southern Sea Otter Military Readiness Areas for national defense purposes, and for other purposes. *"Military Readiness and Southern Sea Otter Conservation Act"*

The Subcommittee on Fisheries, Wildife, Oceans and Insular Affairs was discharged from further consideration of HR 4043 by unanimous consent.

- An amendment offered by Mr. Fleming.001 was AGREED TO by a roll call vote of 19 yeas and 12 nays.
- An amendment offered by Mr. Sablan.001 was NOT AGREED TO by voice vote.

Adopted and favorably reported to the House of Representatives, as amended, by a roll call vote of 24 yeas and 13 nays.

HR 4381, To direct the Secretary of the Interior to establish goals for an all-of-the-above energy production plan strategy on a 4-year basis on all onshore Federal lands managed by the Department of the Interior and the Forest Service. *"Planning for American Energy Act of 2012"*

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of HR 4381 by unanimous consent.

- An amendment offered by Mr. Tipton #1 was AGREED TO by voice vote.
- An amendment offered by Mr. Grijalva.001 was NOT AGREED TO by a roll call vote of 16 yeas and 22 nays.
- An amendment offered by Mr. Holt.002 was NOT AGREED TO by a roll call vote of 14 yeas and 24 nays.
- An amendment offered by Mr. Markey.003 was NOT AGREED TO by a roll call vote of 14 yeas and 24 nays.

Adopted and favorably reported to the House of Representatives, as amended, by a roll call vote of 24 yeas and 14 nays.

HR 4382, To ensure Federal oil and natural gas lease sales occur, eliminate redundant leasing bureaucracy, and provide leasing certainty. "*Providing Leasing Certainty for American Energy Act of 2012*"

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of HR 4382 by unanimous consent.

- An amendment offered by Mr. Holt.007 was NOT AGREED TO by a roll call vote of 14 yeas and 25 nays.
- An amendment offered by Mr. Lujan.004 was NOT AGREED TO by a roll call vote of 18 yeas and 22 nays.
- An amendment offered by Mr. Tonko.003 was NOT AGREED TO by a roll call vote of 15 yeas and 25 nays.
- An amendment offered by Mr. Markey.002 was NOT AGREED TO by a roll call vote of 16 yeas and 25 nays.
- An amendment offered by Mr. Markey.005 was NOT AGREED TO by a roll call vote of 14 yeas and 27 nays

Adopted and favorably reported to the House of Representatives, as amended, by a roll call vote of 24 yeas and 17 nays.

HR 4383, To streamline the application for permits to drill process and increase funds for energy project permit processing, and for other purposes. "*Streamlining Permitting of American Energy Act of 2012*"

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of HR 4383 by unanimous consent.

- An en bloc amendment offered by Mr. Lamborn #1 was AGREED TO by voice vote.
- An amendment offered by Ms. Hanabusa.004 was NOT AGREED TO by a roll call vote of 17 yeas and 24 nays.
- An amendment offered by Ms. Hanabusa.002 was NOT AGREED TO by a roll call vote of 16 yeas and 25 nays.
- An amendment offered by Mr. Holt.001 was NOT AGREED TO by a roll call vote of 15 yeas and 25 nays.

Adopted and favorably reported to the House of Representatives, as amended, by a roll call vote of 25 yeas and 15 nays.

HR 4402, To require the Secretary of the Interior and the Secretary of Agriculture to more efficiently develop domestic sources of the minerals and mineral materials of strategic and critical importance to United States economic and national security and manufacturing competitiveness. "*National Strategic and Critical Minerals Production Act of 2012*"

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of HR 4402 by unanimous consent.

- An amendment offered by Mr. Amodei.001 was AGREED TO by voice vote.
- An amendment offered by Mr. Grijalva.003 was NOT AGREED TO by voice vote.
- An amendment offered by Mr. Tonko.001 was NOT AGREED TO by a roll call vote of 12 yeas and 19 nays.
- An amendment (Mr. Markey.004) offered by Mr. Holt was NOT AGREED TO by a roll call vote of 10 yeas and 24 nays.
