He has also testified before the National Labor Relations Board on matters pertaining to the classification of a pipeline carrier as a public utility.

Mr. Grubich received his Bachelor of Science Degree in Accounting from Central Washington State University and his MBA and Juris Doctor degrees from Gonzaga University. In addition, he practiced law for 6 years as in-house counsel for a large, privately held corporation in Spokane, Washington.
