- (a) The Secretary is authorized and directed to enter into one or more agreements, on terms mutually acceptable to the parties thereto, with the Panoche Water District, Pacheco Water District and San Luis Water District that provide(s) for:
 - (1) the assumption of responsibility by the contracting district for the management of drainage water within such district's boundaries in accordance with federal and state law, on its own behalf or through cooperative regional efforts;
 - (2) the conversion of such district's existing water service contract, or any renewals thereof, entered into under section 9(e) of the Reclamation Project Act of August 4, 1939, 43 U.S.C. § 485h(e), to a repayment contract under section 9(d) of said Act, 43 U.S.C. § 485h(d), including all acts amendatory thereof and supplementary thereto;
 - (3) the relief of such district's repayment obligations for unpaid costs for the Project and properly assignable for ultimate return by such district,
 - (4) the transfer to such district of all right, title and interest, without warranties, in and to the facilities owned by the United States and managed or operated by such district and;

(5) the indemnification of the United States by such district of any and all claims by individual landowners within such district's boundaries, including any and all claims under the Fifth Amendment of the United States Constitution, arising from the alleged failure of the United States to provide drainage or drainage services.

Each agreement described in this subsection shall provide that, except as expressly provided therein, such agreement is not intended to relieve the contracting district of any other obligations under Reclamation Law, including Restoration Fund charges pursuant to section 3407(d) of Public Law 102-575.

- (b) Until the parties reach agreement as provided in subsection (a), the Secretary is directed to implement the obligation of the United States to provide drainage or drainage service to the Pacheco Water District, Panoche Water District and San Luis Water District pursuant to the San Luis Act.
- (c) The Secretary is authorized to develop, in consultation with Panoche Water District, Pacheco Water District, San Luis Water District and districts adjacent to or seeking future use of such portion of the San Luis Drain, a plan for future use of the San Luis Drain from Milepost 105.72, Check 19 (near Russell Avenue) to Milepost 78.5 (Mud Slough)."
