

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 1545
OFFERED BY MR. GRIJALVA OF ARIZONA**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Waco Mammoth Na-
3 tional Monument Establishment Act of 2011”.

4 SEC. 2. DEFINITIONS.

5 In this Act the following definitions apply:

6 (1) NATIONAL MONUMENT.—The term “na-
7 tional monument” means the Waco Mammoth Na-
8 tional Monument, established in section 3.

9 (2) SECRETARY.—The term “Secretary” means
10 the Secretary of the Interior.

11 (3) MAP.—The term “map” means the map ti-
12 tled “Proposed Boundary Waco-Mammoth National
13 Monument”, numbered T21/80,000, and dated
14 April, 2009.

15 SEC. 3. WACO MAMMOTH NATIONAL MONUMENT, TEXAS.

16 (a) ESTABLISHMENT.—There is established the Waco
17 Mammoth National Monument in the State of Texas, as

1 a unit of the National Park System, as generally depicted
2 on the map.

3 (b) AVAILABILITY OF MAP.—The map shall be on file
4 and available for public inspection in the appropriate of-
5 fices of the National Park Service.

6 **SEC. 4. ADMINISTRATION OF NATIONAL MONUMENT.**

7 (a) IN GENERAL.—The Secretary shall administer
8 the national monument in accordance with this Act, the
9 cooperative agreements described in this section, and laws
10 and regulations generally applicable to units of the Na-
11 tional Park System, including the National Park Service
12 Organic Act (39 Stat. 535, 16 U.S.C. 1).

13 (b) COOPERATIVE AGREEMENTS.—The Secretary
14 may enter into cooperative agreements for the manage-
15 ment of the national monument with Baylor University
16 and City of Waco, pursuant to the National Park Service
17 General Authorities Act (16 U.S.C. 1a–2(1)).

18 **SEC. 5. ACQUISITION OF PROPERTY AND BOUNDARY MAN-**
19 **AGEMENT.**

20 (a) ACQUISITION OF PROPERTY.—The Secretary is
21 authorized to acquire from willing sellers lands, or inter-
22 ests in lands, within the proposed boundary of the national
23 monument necessary for effective management.

24 (b) CONDITIONS.—Lands identified in subsection (a)
25 may be acquired—

1 (1) by donation, purchase with donated or ap-
2 propriated funds, transfer from another Federal
3 agency, or by exchange; and

4 (2) in the case of lands owned by the State of
5 Texas, or a political subdivision thereof, or Baylor
6 University only by donation or exchange.

7 **SEC. 6. CONSTRUCTION OF FACILITIES ON NONFEDERAL**
8 **LANDS.**

9 (a) **IN GENERAL.**—The Secretary is authorized, sub-
10 ject to the appropriation of necessary funds, to construct
11 essential administrative or visitor use facilities on non-
12 Federal lands within the national monument.

13 (b) **OTHER FUNDING.**—In addition to the use of Fed-
14 eral funds authorized in subsection (a), the Secretary may
15 use donated funds, property, and services to carry out this
16 section.

17 **SEC. 7. GENERAL MANAGEMENT PLAN.**

18 (a) **IN GENERAL.**—Not later than three years after
19 the date on which funds are made available to carry out
20 this Act, the Secretary, in consultation with Baylor Uni-
21 versity and City of Waco, shall prepare a management
22 plan for the national monument.

23 (b) **INCLUSIONS.**—The management plan shall in-
24 clude, at a minimum—

1 (1) measures for the preservation of the re-
2 sources of the national monument;

3 (2) requirements for the type and extent of de-
4 velopment and use of the national monument;

5 (3) identification of visitor carrying capacities
6 for national monument; and

7 (4) opportunities for involvement by Baylor
8 University, the City of Waco, the State of Texas,
9 and other local and national entities in the formula-
10 tion of educational programs for the national monu-
11 ment and for developing and supporting the national
12 monument.
