Following various technical and management positions in New Orleans, Midland and Houston, he became Operations Technical Manager for the Houston Production Organization, Exxon Company, USA, in 1993.

In July 1995, Mr. Massey transferred to Exxon Australia Limited as Operations Manager for Bass Strait Fields. In August 1998, he transferred to Exxon Corporation as Corporate Production Advisor reporting to the Upstream Executive and Sr. Vice President of the Corporation. Following the merger of Exxon and Mobil in January 2000, Mr. Massey became Deputy Production Manager for ExxonMobil Oil Indonesia.

In November 2001, he returned to Houston, Texas, as Joint Interest Manager U.S., where he was responsible for stewarding Production Company activities for properties in which ExxonMobil has an interest, but does not operate. He was also responsible for activities to commercialize Alaska gas.

Mr. Massey was seconded to his current position with Marine Well Containment Company in February, 2011.
