Over the past five years, the Center has filed on average about 42 lawsuits a year. A significant portion of these (about 28%) are not federal cases, while about 5% of the remainder involve intervention to defend federal agency actions from industry lawsuits. About 56% of the federal cases are brought under the Endangered Species Act, while the remainder include claims under the National Environmental Policy Act, Clean Air Act, Clean Water Act, Freedom of Information Act, National Forest Management Act, and quite a few other federal laws.

Recent federal cases include:

- a suit challenging EPA’s approval of lax water quality standards for Kentucky that are inadequate to protect endangered aquatic wildlife
- a suit against the Coast Guard and EPA based on their failure to update oil spill plans to respond to the massive increase in crude oil transported along the Hudson River
- a suit to protect endangered loggerhead sea turtles from drift gillnets off southern California
- a suit challenging the massive expansion of off-road vehicle trails in Florida’s Big Cypress National Preserve
- a suit to compel the Fish and Wildlife Service to develop a plan to promote the recovery of the critically endangered mountain yellow-legged frog
