I work as the Watershed Manager for the Sauk-Suiattle Indian Tribe, so I am familiar with environmental laws such as the National Environmental Policy Act and the Wilderness Act, both of which came into play in the lawsuit that led to our proposed legislation, but I did not participate in any way as an employee for the Tribe. I simply list it here to demonstrate my professional familiarity with the laws in question.

The Darrington Historical Society joined with the National Trust for Historic Preservation, the Washington (state) Trust for Historic Preservation and the Forest Fire Lookouts Association in filing friends of the court briefs in support of the federal government's defense against a lawsuit by a group called Wilderness Watch. That group sued to force the Forest Service to remove a historic fire lookout on top of Green Mountain. Our partnership of historical and lookout organizations filed friends of the court briefs to provide the U.S. District Court in Seattle with a historical perspective that was otherwise lacking. While our efforts were ultimately unsuccessful in court, we have continued the partnership to pursue what we feel is a more reasonable remedy through a legislative fix. Precedents have been established in which Congress has specifically exempted some fire lookouts from the strict interpretation of the Wilderness Act, which otherwise generally calls for such structures to either be removed or to essentially rot in place. A few narrow exceptions exist in the law for structures deemed necessary for the management of a wilderness area, but Green Mountain Lookout was not found to qualify for that type of exception. Green Mountain Lookout would, however, easily mirror other exemptions Congress has made for fire lookouts that have historical value and support among the general public. My testimony will indicate that Green Mountain Lookout has widespread, bipartisan support, including historical groups and even most of the environmental community, and that the only people who want the lookout removed represent a very narrow minority.
