- **H.R. 919** (Franks of Arizona), To provide for the conveyance of certain public land in Mohave Valley, Mohave County, Arizona, administered by the Bureau of Land Management to the Arizona Game and Fish Commission, for use as a public shooting range. "*Mohave Valley Land Conveyance Act of 2011.*"

- H.R. 2489 (Holt), To authorize the acquisition and protection of nationally significant battlefields and associated sites of the Revolutionary War and the War of 1812 under the American Battlefield Protection Program. "American Battlefield Protection Program Amendments Act of 2011."
- **H.R. 3411** (Benishek), To modify a land grant patent issued by the Secretary of the Interior.
- **H.R. 3440** (Flake), To provide for certain oversight and approval on any decisions to close National Monument land under the jurisdiction of the Bureau of Land Management to recreational shooting, and for other purposes. "*Recreational Shooting Protection Act.*"
