Mr. Chairman, members of the Committee, my name is Dave Nomsen. I am the Vice-president of Governmental Affairs for St. Paul, MN based Pheasants Forever and I reside in Garfield, MN. My primary duties involve supporting a strong framework of federal policies and programs supporting natural resource conservation that complement our habitat-focused mission at Pheasants Forever.

I am pleased to be here today to offer Pheasants Forever's and many others' strong support for H.R. 4315 a bill to amend the Migratory Bird Hunting Stamp Act and Wetland Loan Act. As part of my background, I was a faculty member of the Wildlife Department at South Dakota State University in Brookings, where I worked on various projects related to the function and values of prairie wetlands and directed staff working on the US Fish and Wildlife Services' National Wetlands Inventory across much of the northern Plains. I have served as a member of the North American Wetlands Conservation Council (NAWCC) since 1998.

Pheasants Forever's 650 chapters nationwide complete on average more than 20,000 individual projects annually with conservation minded farmers and ranchers. The vast majority of these projects is completed on private lands and involves grassland establishment and management. Projects involve the establishment of nesting, brood rearing, and winter cover for pheasants, quail, and a wide array of wildlife.

PF chapters also support targeted land acquisitions to improve wildlife habitat and provide public hunting opportunities. Many of these projects include wetland protection and restoration. These projects provide valuable permanent wetland protection, and public recreational opportunities including hunting.

Wetlands provide tremendous public benefit. Wetlands serve as natural filters to reduce soil erosion, filter runoff and improve water quality, and recharge groundwater. Hurricanes Katrina and Rita showed how healthy wetlands provide valuable hurricane damage relief, just as healthy wetland bases within inland watersheds can provide reduced damage from flooding.

Wetlands provide important habitat for hundreds of species of wildlife. I would be remiss if I didn't point out the importance of wetlands to resident wildlife. As wetlands go through periodic drying and reflooding periods they provide important nesting and overwintering habitat for resident wildlife including pheasants and deer.

Dear (members of Congress, Administration officials):

The undersigned organizations representing millions of our nation's sportsmen and sportswomen respectfully request your support for and co-sponsorship of H.R. 4315, a bill to reinstate the Wetlands Loan Act and protect wetland and grassland habitats critical to migratory waterfowl and other wildlife.
