I have worked for 30 years at Conservation Law Foundation on a broad range of marine policy and law issues, primarily focused on New England. I am an author of three published law review articles on federal fisheries management. I was appointed as an adjunct professor of marine policy (including fisheries management policy) at the University of Maine Law School (3 years). I was the lead attorney in successful federal litigation arguing the correct interpretation of various provisions of the Magnuson-Stevens Act. I have attended hundreds of New England Fishery Council meetings, groundfish committee meetings, and related technical meetings. Due to my expertise, I was recommended for council membership by Governor Patrick several years ago; I was not appointed to that position by the Department of Commerce. I was awarded the David B. Stone Award by the New England Aquarium for my marine policy advocacy in fisheries management. I also received a Pew Marine Fellowship in 1996. I am an avid freshwater and saltwater recreational fisherman.


