**Subject:** Full Committee Markup Notice - **REVISED**

On **Wednesday, July 16, 2014 at 10:00 a.m. in 1324 Longworth House Office Building**, the Committee on Natural Resources will hold a markup on the following bills:

- **H.R. 277** (Cicilline), To revise the boundaries of John H. Chafee Coastal Barrier Resources System Sachuest Point Unit RI-04P, Easton Beach Unit RI-05P, Almy Pond Unit RI-06, and Hazards Beach Unit RI-07 in Rhode Island.
- **H.R. 916** (Kind), To improve Federal land management, resource conservation, environmental protection, and use of Federal real property, by requiring the Secretary of the Interior to develop a multipurpose cadastre of Federal real property and identifying inaccurate, duplicate, and out-of-date Federal land inventories, and for other purposes (*Federal Land Asset Inventory Reform Act of 2013*).

- **H.R. 1810** (Clawson), To revise the boundaries of John H. Chafee Coastal Barrier Resources System Gasparilla Island Unit in Florida.
- **H.R. 2158** (Fleming), To exempt from the Lacey Act Amendments of 1981 the expedited removal from the United States of certain snake species, and for other purposes (*Expedited Departure of Certain Snake Species Act*).
- **H.R. 3572** (McIntyre), To revise the boundaries of certain John H. Chafee Coastal Barrier Resources System units in North Carolina.
- **H.R. 3806** (Meadows), To authorize payment of funds in accordance with the agreement entered into by the Tennessee Valley Authority, the State of North Carolina, Swain County, North Carolina, and the United States Department of the Interior (*Great Smoky Mountains National Park Agreement Act of 2013*).

- **H.R. 4751** (Kilmer), To make technical corrections to Public Law 110-229 to reflect the renaming of the Bainbridge Island Japanese American Exclusion Memorial, and for other purposes.
