Subject: Legislative Hearing – June 16, 2015

On **Tuesday, June 16, 2015 at 10:00 a.m. in room 1324 Longworth House Office Building**, the Subcommittee on Federal Lands will hold a legislative hearing on the following bills:

- **H.R. 482 (Rep. Sanford Bishop)**, To redesignate Ocmulgee National Monument in the State of Georgia and revise its boundary, and for other purposes. *“Ocmulgee Mounds National Historical Park Boundary Revision Act of 2015”*
- **H.R. 496 (Rep. Paul Cook)**, To establish the Alabama Hills National Scenic Area in the State of California, and for other purposes. *“Alabama Hills National Scenic Area Establishment Act”*
- **H.R. 959 (Rep. Bennie Thompson)**, To authorize the Secretary of the Interior to conduct a special resource study of the Medgar Evers House, located in Jackson, Mississippi, and for other purposes. *“Medgar Evers House Study Act”*
- **H.R. 1138 (Rep. Michael Simpson)**, To establish certain wilderness areas in central Idaho and to authorize various land conveyances involving National Forest System land and Bureau of Land Management land in central Idaho, and for other purposes. *“Sawtooth National Recreation Area and Jerry Peak Wilderness Additions Act”*
- **H.R. 1554 (Rep. Scott Tipton)**, To require a land conveyance involving the Elkhorn Ranch and the White River National Forest in the State of Colorado, and for other purposes. *“Elkhorn Ranch and White River National Forest Conveyance Act of 2015”*
