**MEMORANDUM**

**Subject:** Full Committee Markup Notice

On **Thursday, November 14, 2013 at 10:00 a.m. in 1324 Longworth House Office Building**, the Committee on Natural Resources will hold a markup on the following bills:

- **H.R. 1308 (Hastings of Washington)**, To amend the Marine Mammal Protection Act of 1972 to reduce predation on endangered Columbia River salmon and other nonlisted species, and for other purposes (*Endangered Salmon and Fisheries Predation Prevention Act*).
- **H.R. 2798 (Latta)**, To amend Public Law 106-206 to direct the Secretary of the Interior and the Secretary of Agriculture to require annual permits and assess annual fees for commercial filming activities on Federal land for film crews of 5 persons or fewer.
- **H.R. 2824 (Johnson of Ohio)**, To amend the Surface Mining Control and Reclamation Act of 1977 to stop the ongoing waste by the Department of the Interior of taxpayer resources and implement the final rule on excess spoil, mining waste, and buffers for perennial and intermittent streams, and for other purposes (*Preventing Government Waste and Protecting Coal Mining Jobs in America*).
- **H.R. 3008 (Capps)**, To provide for the conveyance of a small parcel of National Forest System land in Los Padres National Forest in California, and for other purposes.
- **H.R. 3188 (McClintock)**, To expedite the planning and implementation of salvage timber sales as part of Forest Service and Department of the Interior restoration and rehabilitation activities for lands within the Stanislaus National Forest and Yosemite National Park and Bureau of Land Management lands adversely impacted by the 2013 Rim Fire in California (*Yosemite Rim Fire Emergency Salvage Act*).
- **H.R. 3189 (Tipton)**, To prohibit the conditioning of any permit, lease, or other use agreement on the transfer, relinquishment, or other impairment of any water right to the United States by the Secretaries of the Interior and Agriculture (*Water Rights Protection Act*).
