I am a member in good standing of the Alaska State Bar, United States District Court for the District of Alaska Bar, the Bars of the United States Courts of Appeals for the Fifth and Ninth Circuits and the Bar of the United States Supreme Court.

My professional successes and accomplishments have prompted multiple organizations to feature my work in articles and honor me work with awards. *See e.g.*, The Wilderness Soc’y, 2006 *Honoree*, Arctic Nat’l Wildlife Refuge Prot. Efforts; The Alaska Conservation Found., 2003 *Olaus Murie Award for Outstanding Prof’l Contributions*; The N. Alaska Env’tl Cent., 2002 *Conservationist of the Year*, Mark McCrackin, *Leviathan*, LOQUITUR: ALUMNI MAGAZINE FOR VT. LAW SCHOOL at 9, Fall 2010.

I have extensive experience litigating terrestrial and marine conservation issues in courts, including public lands and oil and gas issues. Recently, I was lead counsel in a successful challenge to the 2007-2012 OCS Oil and Gas Leasing Program. *NVPH v. Interior*, Case No. 07-1344 (D.C. Cir. 2009). I have also practiced in the United States Supreme Court, filing a brief of *amicus curiae* in *United States v. Alaska*, 521 U.S. 1, 117 S. Ct. 1888 (1997). The case concerned the title of land along Alaska’s Arctic Coast, and the majority opinion largely adopted the position advanced in this brief of *amicus curiae*, including arguments that were not raised by parties to the case. My litigation experience in the areas of administrative law, marine environment, and specifically arctic oil and gas is expansive. *See e.g.*, *Trustees for Alaska v. State, Dept. of Natural Res.*, 851 P.2d 1340 (Alaska 1993) (successful challenge to Beaufort Sea offshore oil and gas leasing); *Trustees for Alaska v. State, Dept. of Natural Res.*, 865 P.2d 745 (Alaska 1993) (same); *Ninilchik Traditional Council v. Noah*, 928 P.2d 1206 (Alaska 1996) (successful challenge to Cook Inlet Alaska offshore oil and gas leasing); *Greenpeace v. Nat’l Marine Fisheries Serv.*, 55 F. Supp. 2d 1248 (W.D. Wash. 1999), 80 F. Supp. 2d 1137 (W.D. Wash. 2000), 198 F.R.D. 540 (W.D. Wash. 2000), 106 F. Supp. 2d 1066 (W.D. For the past ten years, I have been an adjunct professor at Vermont Law School, home to the nation’s top environmental law program. As a professor, I develop and teach courses related to marine conservation and the management of human uses of the marine environment, including oil and gas development, marine fisheries, shipping, tourism.

ARCTIC: THE ARCTIC NATIONAL WILDLIFE REFUGE - IN THE FAR NORTHEAST CORNER OF ALASKA LIES ONE OF AMERICA'S GREAT NATURAL TREASURES, THE 19 MILLION-ACRE ARCTIC NATIONAL WILDLIFE REFUGE. IT IS CONSIDERED THE CROWN JEWEL OF AMERICA'S NATIONAL WILDLIFE REFUGE SYSTEM. THIS TRULY UNDISTURBED WILDERNESS - A LAST VESTIGE OF THE AMERICAN FRONTIER THAT HELPED SHAPE AND DEFINE OUR NATIONAL IDENTITY - IS TODAY IN GRAVE DANGER OF BEING DESTROYED BY THOSE SEEKING WHATEVER OIL MIGHT LIE BENEATH ITS FRAGILE TUNDRA. ALASKA WILDERNESS LEAGUE (AWL) IS CONTINUING THEIR WORK TO GAIN PERMANENT PROTECTION IN CONGRESS FOR THIS SPECTACULAR AREA.

FORESTS: ALASKA'S MAJESTIC RAINFOREST - BEAUTIFUL, LUSH AND REMOTE, AMERICA'S RAINFOREST IN ALASKA SCRIBES A THOUSAND-MILE ARC ALONG THE ROCKY FJORDS OF THE SOUTH-CENTRAL COAST AND SOUTHEAST PANHANDLE OF ALASKA. WITH ITS TOWERING CEDARS, HEMLOCKS AND SITKA SPRUCE, THE LUSH FORESTS OF COASTAL ALASKA CONTAIN 40 PERCENT OF THE WORLD'S REMAINING TEMPERATE RAINFOREST. IT IS HOME TO THE WORLD'S HEALTHIEST REMAINING POPULATIONS OF WILD SALMON, GRIZZLY BEARS AND BALD EAGLES. ALMOST ALL OF THIS SPECIAL LAND LIES WITHIN THE TONGASS AND CHUGACH, OUR COUNTRY'S TWO LARGEST NATIONAL FORESTS. UNFORTUNATELY MORE THAN HALF OF THE BIGTREE, OLD-GROWTH FOREST IN THE TONGASS HAS ALREADY BEEN LOST AS A RESULT OF NEARLY SIX DECADES OF CLEAR CUT LOGGING. AWL IS WORKING TO ENSURE THAT CONGRESS PROVIDES PERMANENT PROTECTION FOR THE MILLIONS OF

NATIONAL PETROLEUM RESERVE ALASKA (WESTERN ARCTIC) - AWL IS INVOLVED IN PROTECTING SPECIAL PLACES IN THE WESTERN ARCTIC, WHICH PROVIDE ESSENTIAL SUMMER HABITATS FOR MILLIONS OF WATERFOWL AND IS ONE OF THE LARGEST WILD AREAS REMAINING IN THE WORLD. THE 23.5-MILLION-ACRE RESERVE IS THE LARGEST SINGLE BLOCK OF PUBLIC LAND IN THE UNITED STATES. IT STRETCHES FROM THE BROOKS RANGE NORTHWARD TO THE BEAUFORT AND CHUKCHI SEAS OF THE ARCTIC OCEAN. IT IS HOME TO A WIDE DIVERSITY OF WILDLIFE IN A VARIETY OF ARCTIC ECOSYSTEMS AND SUPPORTS THE SUBSISTENCE LIFESTYLE OF MANY NATIVE ALASKANS. THOUGH NOT AS WELL KNOWN AS THE ARCTIC NATIONAL WILDLIFE REFUGE IN NORTHEAST ALASKA, THE RESERVE IS THE BIOLOGICAL BACKBONE OF ALASKA'S WESTERN ARCTIC.




