## **Organizations Support Republican Legislation to Expand American Energy Production, Create Jobs, & Lower Gas Prices**

Over 25 groups from across the country are calling for passage of legislation to expand American energy production. From groups focused on economic development to seniors issues to fiscal conservatism, these organizations have come together to support H.R. [2231](#), the Offshore and Energy Jobs Act, which could create 1.2 million jobs long-term and generate \$1.5 billion in new revenue to the U.S. Treasury.

“For too long, the federal government’s barriers have blocked production of America’s energy resources...We applaud your efforts to respond to the overwhelming concern America’s seniors and soon-to-be seniors have about the threat energy dependence on foreign resources has on our national security and economic stability.”

“Current federal policies directly and indirectly encourage new demand for natural gas in several important end markets, including power generation, transportation and as an export commodity. “CEA believes that expanded offshore energy development is vital to long-term energy security and affordability and economic expansion. According to a 2010 assessment by IHS Global Insight, the offshore Gulf of Mexico oil and natural gas industry generated almost \$70 billion of economic value and supported nearly 400,000 jobs in 2009. That same year, the industry provided about \$20 billion in revenues to federal, state and local governments through royalties, bonuses and rents. Further expansion of access, particularly in offshore areas currently off-limits, could boost domestic energy production and grow the economy.”

“EPSC believes that expanded domestic energy development is vital to economic growth and job creation. In the midst of the recent economic downturn, the energy sector led economic growth and job creation and will likely continue to do so. “The Offshore Energy and Jobs Act would allow the United States to take better advantage of an incredible amount of natural resources in the outer Continental Shelf area, which is considered to have the largest undiscovered, technically recoverable oil and gas resources. Heritage has explained the government needs to move aside and let private industry operate freely, especially in light of the weak U.S. economy. Doing so would help create jobs and increase our domestic oil production, which would in turn save American families money.”

“According to a study by Wood Mackenzie Energy Consulting, policies that encourage domestic oil and gas exploration could add 1.1 million jobs by 2020 and four million barrels’ worth of oil and natural gas per day. There is no questioning our nation’s abundance of oil and natural gas resources. “NFIB supports expanding domestic energy production, including lifting moratoriums on offshore drilling. The U.S. Bureau of Ocean Energy, Management, Regulation and Enforcement estimates that America’s Outer Continental Shelf contains nearly 86 billion barrels of oil, enough oil to replace OPEC imports for 50 years. Lifting the OCS ban is important in meeting our nation’s energy needs, breaking our dependence on foreign oil, and reducing prices for American small businesses, their employees and consumers. Increasing fuel prices hit small businesses particularly hard, because unlike their larger competitors, they often absorb these cost increases instead of passing them on to their customers.”

"The Offshore Energy Jobs Act capitalizes on the extraordinary energy opportunity facing America today. While the United States has closed offshore areas to exploration, other countries are exploring off their coasts. ### **Shallow Water Energy Security Coalition**

“While 20 percent of our nation’s oil and gas production comes from the offshore, the Department of the Interior estimates that there are 86 billion barrels of oil and 420 cubic feet of gas on the Outer Continental Shelf. Under the current Administration’s 5-Year Plan on the Outer Continental Shelf (“OCS”), approximately 85% of our offshore areas remain off limits to energy exploration and production. Therefore, current policy keeps the public in the dark about the full potential of the OCS in meeting our nation’s energy challenges. While policy-makers have great differences about the future direction of U.S. energy policy, there is a stated consensus that in order to solve our nation’s energy challenges, we need an all-of-the-above energy strategy. The Hastings Bill is part of the solution.”
