Dear Ms. Suh:

On June 5, 2018, the Committee on Natural Resources wrote the Natural Resources Defense Council (NRDC)¹ seeking clarification on the nature of the NRDC's advocacy work to influence U.S. environmental and natural resources policy based on your organization's relationships with foreign entities.² Specifically, the Committee expressed its concerns that the NRDC's need to maintain access to Chinese officials has influenced its political activities in the United States and may require compliance with the Foreign Agents Registration Act (FARA).³

While we appreciate the NRDC's responses to most of the Committee's preliminary questions, further questions exist related to NRDC's relationship with the Chinese government. The NRDC's ability to work in the People's Republic of China is dependent on the goodwill of the Chinese government.⁴ We are aware that NRDC leadership regularly meets with senior Chinese and Communist Party officials.⁵

- Documents sufficient to list all persons serving as senior leadership, policy experts, or members of the board of trustees who have or currently engage in any work by the NRDC referring or related to China from January 1, 2002 to the present;
- 2. Documents sufficient to identify the referenced "policies and procedures relating to government grants and political activities" per the NRDC's June 25, 2018 supplemental response to the Committee;
- 3. Documents sufficient to identify any Chinese official, Chinese national, or Chinese business interest, including their agents, representatives, or intermediaries that the NRDC has engaged with as part of the NRDC's efforts to formulate, adopt, or change domestic or foreign environmental or natural resources policies or laws of the United States or to influence U.S. public opinion;
- 4. All documents and communications, including but not limited to, internal memoranda, contracts, cooperative agreements, and emails, between the NRDC, or any of its agents, and any Chinese official, Chinese national, or Chinese business interest, including their agents, representatives, or intermediaries, referring or relating to the domestic or foreign environmental or natural resources policies or laws of the United States or to influence U.S. public opinion;
- 5. All documents and communications, including but not limited to, internal memoranda and emails, between the NRDC, or any of its agents, and any official, employee, or agent of the United States government referring or relating to the domestic or foreign environmental or natural resources policies or laws of the United States or of the People's Republic of China;
- 6. Documents sufficient to identify any policies or procedures the NRDC has implemented to ensure compliance with the "Law of the People's Republic of China on Administration of Activities of Overseas Nongovernmental Organizations in the Mainland of China," including compliance with registration, activity specifications, and oversight and supervision requirements;
- 7. A document sufficient to list all trips made, by the NRDC trustees, employees, or agents to the People's Republic of China with corresponding dates and itinerary from January 1, 2002 to present;

A document sufficient to list all meetings during visits to the United States, with corresponding dates and itineraries, by any Chinese national, including their agents, representatives, or intermediaries, where any portion of the trip was arranged, facilitated, or subsidized, in whole or in part, by the NRDC from January 1, 2002 to present; and
- 9. A document sufficient to identify any former or current NRDC employees, or agents, who have ever been employees, appointees, agents, or officials of any Chinese corporation, government agency, or political sub-division of the People's Republic of China, with corresponding dates of employment and position while at the NRDC and while at the Chinese entity.
