Dear Ms. Dillen:

The House Committee on Natural Resources (Committee) is conducting oversight related to Earthjustice's efforts to derail the widely supported bipartisan Willow Project (Willow).<sup>1</sup> The Committee is particularly concerned with Earthjustice's coordination with other activist environmental groups, many of which employ lawfare strategies, including ethically dubious sue and settle tactics,<sup>2</sup> to not only champion a disdain for established essential multiple use principles, but also drown out the voices of native Alaskans while simultaneously undermining American energy independence.<sup>3</sup>

Willow has long received overwhelming bipartisan support to bring Alaska's vast North Slope oil resources to market, not only in the state of Alaska, but also across the United States.<sup>4</sup> Willow, with a gravel footprint of approximately 385 acres in the northeast of the 23 million-acre National Petroleum Reserve-Alaska (NPR-A), is estimated to be able to produce up to 180,000 barrels of oil daily at its peak, totaling about 600 million barrels of recoverable oil.<sup>5</sup>

Alaska's natural oil resources are critical to establishing and maintaining American energy independence. According to the Bureau of Land Management (BLM), without Willow, the U.S. will need to import more than half of the lost oil resources from foreign sources. Relying on foreign sources for our energy needs weakens America's global energy standing, and funds energy operations abroad that employ weaker environmental standards when compared to U.S. domestic producers.<sup>6</sup>

The economic benefits of these North Slope oil resources are invaluable. Willow is estimated to generate up to \$17.1 billion in federal, state, and local royalties and tax revenues.<sup>7</sup> Because the project will require approximately nine million work hours, Willow is estimated to create about 2,500 construction jobs and 300 long-term, stable, high-paying jobs that will directly benefit native Alaskan communities in and around the NPR-A.<sup>8</sup>

Unsurprisingly, the strategic and economic benefits of the project elicit overwhelming support from native Alaskans for Willow, especially from those who live in and around the North Slope.<sup>9</sup> Yet, Earthjustice appears determined to ignore Willow's indispensability, undermine American energy security, and obstruct native Alaskan prosperity through its unscrupulous coordinated litigation tactics.

In 2018, Willow began its formal development permitting process.<sup>10</sup> In 2020, BLM published its final Environmental Impact Statement (EIS) and Willow Master Development Plan Record of Decision (ROD).<sup>11</sup> That same year, Earthjustice and several other activist organizations conjured up bogus environmental and procedural claims to sue the federal government to derail Willow.<sup>12</sup> In 2023, the Biden Administration's BLM and the U.S. Department of the Interior (DOI) published a final supplemental EIS and an updated ROD allowing Willow to progress.<sup>13</sup>

Unhappy with the project's reapproval despite crushing bipartisan support, Earthjustice and its preservationist partners again sued to stop Willow.<sup>14</sup> Boldly, though unsurprisingly, Earthjustice and its partners expected the same taxpayers harmed by this vexatious litigation to pay for it through exploitation of the Equal Access to Justice Act (EAJA).<sup>15</sup> In November 2023,

Earthjustice's effort was quashed by the U.S. District Court for the District of Alaska upholding the updated Willow ROD.<sup>16</sup> Unfortunately cursed with an unquenchable thirst to subvert American energy independence, Earthjustice and other activist groups continued to wage lawfare against Willow until June 2025, when the U.S. Court of Appeals for the Ninth Circuit largely upheld Willow's approval but required that BLM address a lone minor procedural "error."<sup>17</sup>

Given Earthjustice's questionable litigation strategies and the importance of Willow to Alaskan economic prosperity and American energy security, the Committee is keen to uncover the details of Earthjustice's opposition to the project. Accordingly, the Committee hereby requests that Earthjustice provide the following documents and information in your possession, custody, or control, in complete, unredacted, and electronic format, as soon as possible but no later than March 5, 2026:

1. All documents and communications among or between Earthjustice, Natural Resources Defense Council (NRDC), Defenders of Wildlife (Defenders), Center for Biological Diversity (CBD), Friends of the Earth (Friends), Greenpeace USA (Greenpeace), DOI, BLM, U.S. Fish and Wildlife Service (FWS), U.S. National Marine Fisheries Service (NMFS), National Oceanic and Atmospheric Administration (NOAA), or U.S. Department of Commerce (DOC) related to Willow from January 2020 to present.
2. All communications among or between Earthjustice, NRDC, Defenders, CBD, Friends, Greenpeace, and any Russian, Chinese, Iranian, or North Korean nationals, or any representatives or affiliates thereof, related to Willow from January 2020 to present.
3. Documents and communications sufficient to show dates, attendees, agendas, and minutes of any meetings among or between Earthjustice, NRDC, Defenders, CBD, Friends, Greenpeace, DOI, BLM, FWS, NMFS, NOAA, or DOC related to Willow from January 2020 to present.
4. Documents and communications sufficient to show all litigation costs—including but not limited to attorney's fees, hours, salaries, bonuses, filing fees, and other expenses—incurred by Earthjustice, NRDC, Defenders, CBD, Friends, or Greenpeace for which Earthjustice, NRDC, Defenders, CBD, Friends, or Greenpeace sought reimbursement under EAJA from January 2020 to present.
5. All documents and communications among or between Earthjustice, NRDC, Defenders, CBD, Friends, Greenpeace, DOI, BLM, FWS, NMFS, NOAA, or DOC related to EAJA from January 2020 to present.
