
# HENRY M. CAGEY



### I. <u>Experience</u>

**Lummi Indian Business Council**. Member, 2012 to present; Chairman, 1991-1998. Duties include serving as official governmental representative of the Lummi Nation, a sovereign nation recognized by the United States of America pursuant to the Treaty of Point Elliott of 1855.

- National Government Relations: Advanced issues such as Education, Health, Housing, Natural Resources, Water Resources and Economic needs for the tribe. Conducted government-to-government meetings with congressional delegates, Agency Officials, Department Heads and National Organizations. 1991-1998.
- **Regional Government Relations**: Engaged with the State of Washington, including government-to-government relations, Health & Human Services, Natural Resources, Environmental Issues, Education and Gaming.
- **Tribal Government Relations**: As Chairman, represented the Lummi Nation with coordination with national and regional tribal governments and tribal organizations.

**Lummi Economic Development Director**. January 2004 to present. Duties include: Oversee the economic analysis of business proposals and opportunities, working with a 9 member board developing economic strategies, assisting tribal clients with small business development. Develop quarterly and annual reports, and monitoring budgets. Supervising all Economic Development employees.

#### Lummi Vocational Rehabilitation Counselor, 1988-1990.

Partnership grant with the State of Washington and the Lummi Nation to provide vocational rehabilitation services to Lummi members. Negotiated employment opportunities for clients. Assisted clients in job placement and follow up. Case load approximately 60-70 clients.

#### Tribal Employment Rights Director, 1984-1988.

Uphold employment ordinance for job placement for Indian preference. Funding source is the Equal Employment Opportunity Commission. Investigated discrimination

complaints. Filing discrimination complaints with EEOC. Negotiated with off reservation employers for placement of Indians.

#### Lummi Natural Resources Enforcement Officer, 1983-1984.

Enforced the Lummi Nation's Title 10 Code. Patrolled Usual and Accustomed areas. Issuing reports and citations for violations.

#### II. <u>Accomplishments</u>

- Served a lead role on behalf of Lummi Nation in gaining passage of the Tribal General Welfare Exclusion Act of 2014, which permanently immunized from federal income taxation most benefits provided by tribal governments to their citizens
- Served a lead role on behalf of the Lummi Nation in gaining passage of 26 U.S.C. § 7873, which permanently immunized from federal income taxation income derived from exercising Indian treaty fishing rights
- Served a lead role in interacting with U.S. federal agencies to secure funding for the Lummi Nation
  - Lummi Shore Road Project for \$7.3 million
  - o Lummi Housing Authority in the amount of \$4.2 million
  - Dislocated Worker Program for \$4 million
  - Assisted Living Center for \$3 million
  - \$5.2 million from BIA under IHS
