

IN 2012, R STREET PUBLISHED ITS FIRST REPORT CARD AS AN INDEPENDENT THINK TANK, AS WELL AS RESEARCH ON FREE-MARKET REFORMS IN FLORIDA AND THE FIRST ECONOMETRIC STUDY OF THE IMPACT OF FEDERAL SUBSIDIES TO EARTHQUAKE INSURANCE. IN 2013, R STREET HAS PUBLISHED FURTHER STUDIES ON AUTO INSURANCE MARKETS IN MICHIGAN AND NORTH CAROLINA AND THE PROPERTY INSURANCE MARKET IN SOUTH CAROLINA. IN ADDITION TO INSURANCE, R STREET'S FINANCIAL SERVICES PROGRAM ENCOMPASSES CREDIT UNION REFORM, PUBLISHING A MAJOR PAPER ON THE SUBJECT OF SMALL BUSINESS LENDING IN 2012, AS WELL AS A SHORTER PAPER ON MONEY MARKET FUNDS IN 2013. LATER

IN 2012, THE PROGRAM CLAIMED SUCCESS RIGHT OUT OF THE GATE WITH PASSAGE OF THE BIGGERT-WATERS FLOOD INSURANCE REFORM ACT, WHICH INCLUDES A NUMBER OF R STREET PROPOSALS TO PHASE OUT SUBSIDIES TO DEVELOPMENT IN COASTAL ZONES AND SENSITIVE WETLANDS.
