**I was raised on the Spirit Lake Reservation. I am an enrolled member of the tribe. I worked for the tribal ICWA program as a secretary from October 1992 until May 1994. I earned my associate degree in Criminal Justice at United Tribes Technical College in December 1997. I earned my bachelor’s degree in Criminal Justice from Minot State University in May 2000 while working at the North Dakota State Penitentiary as a correctional officer. I was hired as a U.S. Probation & Pretrial Services Officer for the District of North Dakota in October 2000. I was specifically hired to work with my home reservation, Spirit Lake. A majority of my cases were crimes that occurred on the Spirit Lake Reservation. I became familiar with the justice process with cases from Spirit Lake, having to work within the pretrial phase, trial phase and conviction phase. Because of this experience, I became knowledgeable in the all aspects of the federal judicial system especially cases within Indian Country. In February 2010, I was appointed as Associate/Juvenile Judge for the Spirit Lake Tribal Court. I handled all juvenile cases which included delinquency, custody, ICWA and Spirit Lake Social Services cases. I also handled a majority of cases in adult criminal court. While working at the Spirit Lake Tribal Court, I completed a number of training courses at the National Judicial College which included Essential Skills for Tribal Court Judges and Advanced Tribal Bench Skills.**

**While I worked at the Spirit Lake Tribal Court, I witnessed on several occasions the incompetence of the BIA Law Enforcement along with the Spirit Lake Tribal Social Services. It is my understanding these issues still exist and there is no one holding these agencies accountable. The members of Spirit Lake Tribe deserve to feel as safe and secure as any other citizen within the United States. But this is not the case. One more note: all officers who consistently failed to provide documentation in court, who failed to show up for trials, who failed to complete investigations, etc. are all still working at BIA Police Department in Fort Totten, North Dakota. The current Chief of Police was and is aware of all these issues with law enforcement yet, does nothing to address them.**
