The Alaska Native Tribal Health Consortium (ANTHC) is a non-profit tribal health organization. The Consortium is the largest, most comprehensive tribal health organization in the United States, and Alaska's second-largest health employer with more than 2,400 employees offering an array of health services to people throughout the state. The Consortium has four operating divisions: Alaska Native Medical Center (ANMC), Community Health Services, Environmental Health & Engineering, and Business Support. Its largest division, ANMC, is a 150-bed hospital and provides specialty and tertiary care health services to Alaska Native and American Indian people residing in Alaska, spanning distances equivalent to two-thirds of the United States. ANTHC has an annual budget of \$535 million.

- ❖ Develops and builds consensus for a vision of success for the Consortium.
- ❖ Provides direction to the CEO and executive leaders of the largest non-profit tribal health organization in the nation, which consists of a consortium of 229 Tribes, 25 Tribal Health Organizations, employs 2,400 staff and serves 147,000 people.
- ❖ Governs the Alaska Native Medical Center, a 154-bed, Level II Trauma Center providing primary and tertiary hospital services as well as the associated multi-specialty physician clinics.
