

COMMITTEE MARKUP ACTION

The Committee on Natural Resources met in open session on Wednesday, September 9, 2015, and reconvened on Thursday, September 10, 2015, to consider the following bills:

H.R. 538 (Rep. Don Young), To facilitate the development of energy on Indian lands by reducing Federal regulations that impede tribal development of Indian lands, and for other purposes. "Native American Energy Act"

The Subcommittee on Indian, Insular and Alaska Native Affairs and Subcommittee on Energy and Mineral Resources were discharged from further consideration

An Amendment offered by Mr. Grijalva (042), was not adopted by a roll call vote of 10 yeas and 22 nays.

H.R. 538 was adopted and favorably reported to the House of Representatives by a roll call vote of 23 yeas and 12 nays.

H.R. 1541 (Rep. Raul Grijalva), To amend title 54, United States Code, to make Hispanic-serving institutions eligible for technical and financial assistance for the establishment of preservation training and degree programs. "PRISM Act"

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 1541 by unanimous consent.

An Amendment offered by Ms. Bordallo (001), was adopted by voice vote.

H.R. 1541, as amended, was adopted and favorably reported to the House of Representatives by voice vote.

H.R. 1644 (Rep. Alexander Mooney), To amend the Surface Mining Control and Reclamation Act of 1977 to ensure transparency in the development of environmental regulations, and for other purposes. "STREAM Act"

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of H.R. 1664 by unanimous consent.

An Amendment in the Nature of a Substitute offered by Mr. Mooney (002), was adopted by voice vote.

An Amendment to the Mooney ANS offered by Mr. Lowenthal (001), was not adopted by a roll call vote of 12 yeas and 23 nays.

H.R. 1644, as amended, was adopted and favorably reported to the House of Representatives by a roll call vote of 23 yeas and 12 nays.

H.R. 1880 (Rep. Michelle Lujan Grisham), To require the Secretary of the Interior to take into trust 4 parcels of Federal land for the benefit of certain Indian Pueblos in the State of New Mexico. “Albuquerque Indian School Land Transfer Act”

The Subcommittee on Indian, Insular and Alaska Native Affairs was discharged from further consideration of H.R. 1880 by unanimous consent.

H.R. 1880 was adopted and favorably reported to the House of Representatives by unanimous consent.

H.R. 2130 (Rep. Mac Thornberry), To provide legal certainty to property owners along the Red River in Texas, and for other purposes. “Red River Private Property Protection Act”

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 2130 by unanimous consent.

An Amendment in the Nature of a Substitute offered by Mr. Bishop of Utah (016), was adopted by voice vote.

H.R. 2130, as amended, was adopted and favorably reported to the House of Representatives by a roll call vote of 21 yeas and 11 nays.

H.R. 2168 (Rep. Jamie Herrera Beutler), To make the current Dungeness crab fishery management regime permanent and for other purposes. “West Coast Dungeness Crab Management Act”

The Subcommittee on Water, Power and Oceans was discharged from further consideration of H.R. 2168 by unanimous consent.

H.R. 2168 was adopted and favorably reported to the House of Representatives by unanimous consent.

H.R. 2288 (Rep. Bob Goodlatte), To remove the use restrictions on certain land transferred to Rockingham County, Virginia, and for other purposes.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 2288 by unanimous consent.

An Amendment offered by Mr. McClintock (#1), was adopted by unanimous consent.

H.R. 2288, as amended, was adopted and favorably reported to the House of Representatives by unanimous consent.
