- H.R. 3144 (Rep. Cathy McMorris Rodgers), To provide for operations of the Federal Columbia River Power System pursuant to a certain operation plan for a specified period of time, and for other purposes.
- H.R. 3392 (Rep. Mike Johnson), To provide for stability of title to certain land in the State of Louisiana, and for other purposes. "Lake Bistineau Land Title Stability Act";
- H.R. 3997 (Rep. Keith J. Rothfus), To waive the application fee for any special use permit for veterans demonstrations and special events at war memorials on Federal land, and for other purposes. "Free Veterans from Fees Act";
- H.R. 4257 (Rep. Chris Stewart), To maximize land management efficiencies, promote land conservation, generate education funding, and for other purposes. "Advancing Conservation and Education Act"; and
- H.R. 5005 (Rep. Al Lawson, Jr.), To direct the Secretary of the Interior to conduct a special resource study to determine the suitability and feasibility of establishing the birthplace of James Weldon Johnson in Jacksonville, Florida, as a unit of the National Park System.
