Subject: Full Committee Markup Notice

The Committee on Natural Resources has scheduled a markup beginning on **Wednesday, July 11, 2018, at 10:15 a.m.** The Committee will consider the following bills:

- **H.R. 577 (Rep. Dina Titus)**, To designate a peak in the State of Nevada as Maude Frazier Mountain;
- **H.R. 1482 (Rep. Michael K. Simpson)**, To authorize the Secretary of Agriculture to maintain or replace certain facilities and structures for commercial recreation services at Smith Gulch in Idaho, and for other purposes;
- **H.R. 3764 (Rep. Greg Gianforte)**, To extend the Federal recognition to the Little Shell Tribe of Chippewa Indians of Montana, and for other purposes. *“Little Shell Tribe of Chippewa Indians Restoration Act of 2017”*;
- **H.R. 5613 (Rep. Kevin Yoder)**, To designate the Quindaro Townsite in Kansas City, Kansas, as a National Historic Landmark, and for other purposes. *“Quindaro Townsite National Historic Landmark Act”*;
- **H.R. 6077 (Rep. Tom Reed)**, Recognizing the National Comedy Center in Jamestown, New York. *“National Comedy Center Recognition Act”*; and
- **H.R. 6302 (Rep. Jack Bergman)**, To enact as law certain regulations relating to the taking of double-crested cormorants.

On Wednesday, July 11, 2018, the Committee will convene at 10:15 a.m. in 1324 Longworth House Office Building for a Full Committee Markup.

Note that all bipartisan amendments, and amendments filed by this time, will be given priority recognition at the markup.
