**A BILL**

To authorize the Secretary of the Interior to recover the cost of processing administrative protests for oil and gas lease sales, applications for permits to drill, and right of way applications, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Removing Barriers to  
5 Energy Independence Act”.

1 **SEC. 2. ADMINISTRATIVE PROTEST PROCESS REFORM.**

2 Section 17 of the Mineral Leasing Act (30 U.S.C.  
3 226) is amended by adding at the end the following:

4 “(q) PROTEST FILING FEE.—

5 “(1) IN GENERAL.—Before processing any pro-  
6 test filed under this section, the Secretary shall col-  
7 lect a filing fee from the protestor to recover the  
8 cost for processing documents filed for each adminis-  
9 trative protest.

10 “(2) AMOUNT.—The filing fee shall be cal-  
11 culated as follows:

12 “(A) For each protest filed in a submission  
13 not exceeding 10 pages in length, the base filing  
14 fee shall be \$150.

15 “(B) For each submission exceeding 10  
16 pages in length, an addition to the base filling  
17 fee, an assessment of \$5 per page in excess of  
18 10 pages shall apply.

19 “(C) For protests that include more than  
20 one oil and gas lease parcel, right-of-way, or ap-  
21 plication for permit to drill in a submission, an  
22 additional assessment of \$10 per additional  
23 lease parcel, right-of-way, or application for  
24 permit to drill shall apply.

25 “(3) ADJUSTMENT.—

1           “(A) IN GENERAL.—Beginning on January  
2           1, 2020, and annually thereafter, the Secretary  
3           shall adjust the filing fees established in this  
4           subsection to whole dollar amounts to reflect  
5           changes in the Producer Price Index, as pub-  
6           lished by the Bureau of Labor Statistics, for  
7           the previous 12 months.

8           “(B) PUBLICATION OF ADJUSTED FILING  
9           FEES.—At least 30 days before the filling fees  
10          as adjusted under this paragraph take effect,  
11          the Secretary of the Interior shall publish noti-  
12          fication of the adjustment of such fees in the  
13          Federal Register.”.
