Amendment to H.R. 820 Offered by Mr. Westerman

Amend the long title to read as follows:

To establish the New Philadelphia National Historic Site in the State of Illinois as a unit of the National Park System, and for other purposes.

Page 1, line 5, strike "Historical Park" and insert "Historic Site".

Strike section 2 and redesignate existing provisions accordingly.

Page 2, line 11, strike "site" and insert "townsite".

Page 2, strike lines 15 and 16 and insert the following:

- (1) HISTORIC SITE.—The term "Historic Site" means the New Philadelphia National Historic Site established by this Act.
- (2) MAP.—The term "Map" means the map titled "New Philadelphia National Historic Site Proposed Boundary", numbered 591/176,516, and dated July, 2021.

Page 2, line 17, strike "(2)" and insert "(3)".

Page 2, line 19, strike "(3)" and insert "(4)".

Beginning on page 2, strike line 22 and all that follows through page 3, line 7 and insert the following:

(a) ESTABLISHMENT.—Subject to paragraph (c), there is established the New Philadelphia National Historic Site in the State of Illinois as a unit of the National Park System to preserve, protect, and interpret the history and archeological resources of the town established by Frank McWorter, a formerly enslaved man, in 1836.

Page 3, strike lines 8 through 11 and insert the following:

- (b) BOUNDARY.—The boundaries of the Historic Site shall be the boundaries generally depicted on the Map.
- (c) SECRETARIAL DETERMINATION.—The Historic Site shall not be established until the date on which the Secretary determines that the Secretary has acquired a sufficient quantity of land or interests in and within the boundary of the Historic Site to constitute a manageable unit.
- (d) NOTICE.—Not later than 30 days after the date on which the Secretary makes a determination under subsection (c), the Secretary shall publish in the Federal Register notice of the establishment of the Historic Site.

Page 3, line 14, strike "Park" and insert "Historic Site".

In section 5(b), strike "Park" each place it appears and insert "Historic Site".

Page 4, line 10, strike "for inclusion in the Park".

Page 4, beginning on line 11, strike "buildings, or structures owned by the State or any other political, private, or nonprofit entity" and insert "within the Historic Site boundary".

Page 4, page 13, insert "using donated or appropriate funds" after "seller".

Page 4, strike lines 14 through 19 and redesignate the remaining provisions accordingly.

Page 4, line 20, strike "fiscal".

Page 4, line 24, strike "Park" and insert "Historic Site".

Page 4, beginning on line 24, strike the long dash and all that follows through page 5, line 3, and insert "section 100502 of title 54, United States Code.".

Page 5, strike lines 15 through 17.
