I have been the sued by the U.S. in the case *U.S. v Wayne N. Hage, Executor of the Estate of E. Wayne Hage, and Wayne N Hage, Individually*. Case No. 2:07-cv-01154-RCJ-VCF brought by the Department of Interior BLM and Department of Agriculture USFS in which case the two above mentioned agencies were found in conspiracy against my family by the United States District Court of the District of Nevada.

Below is a list of all published decisions in the cases mentioned above as well as related cases involving my father and mother, the estates of my father and mother and/or me individually. That ruling was ultimately overturned by the 9th Circuit Court of Appeals. Notably, charges in this case were brought **four months** after my mother and father filed their 1991 Constitutional Fifth Amendment takings case in the U.S. Court of Federal Claims.
