National Marine Fisheries Service et al.*, Case No. 3:11-cv-00001-TMB in U.S. District Court for the District of Alaska. This case has been partially consolidated with *State of Alaska v. Lubchenco et al.*, Case No. 3:10-cv-00271-TMB and *Freezer Longline Coalition v. Lubchenco et al.*, Case No.: 11-cv-00004 TMB. The lawsuit challenges the current Steller sea lion biological opinion and associated Reasonable and Prudent Alternative under the Administrative Procedure Act, the Endangered Species Act, the Magnuson-Stevens Fishery Management and Conservation Act, and the National Environmental Policy Act.
