Subject: Full Committee Markup Notice

On **Thursday, June 19, 2014 at 10:00 a.m. in 1324 Longworth House Office Building**, the Committee on Natural Resources will hold a markup on the following bills:

• H.R. 2455 (Amodei), To provide for the sale or transfer of certain Federal lands in Nevada, and for other purposes. *"Nevada Native Nations Lands Act"*

- H.R. 3716 (Amodei), To ratify a water settlement agreement affecting the Pyramid Lake Paiute Tribe, and for other purposes. "*Pyramid Lake Paiute Tribe Fish Springs Ranch Settlement Act*"
- **H.R. 4049** (Duffy), To amend the Act to provide for the establishment of the Apostle Islands National Lakeshore in the State of Wisconsin, and for other purposes, to adjust the boundary of that National Lakeshore to include the lighthouse known as Ashland Harbor Breakwater Light, and for other purposes. *"Ashland Breakwater Light Transfer Act"*
- **H.R. 4283** (Simpson), To amend the Wild and Scenic Rivers Act to authorize the Secretary of the Interior to maintain or replace certain facilities and structures for commercial recreation services at Smith Gulch in Idaho, and for other purposes.
- **H.R. 4489** (Cleaver), To designate memorials to the service of members of the United States Armed Forces in World War I, and for other purposes. *"World War I Memorial Act of 2014"*
- **H.R. 4508** (Daines), To amend the East Bench Irrigation District Water Contract Extension Act to permit the Secretary of the Interior to extend the contract for certain water services.
- **H.R. 4527** (Michaud), To remove a use restriction on land formerly a part of Acadia National Park that was transferred to the town of Tremont, Maine, and for other purposes.
- **H.R. 4562** (Smith of Nebraska), To authorize early repayment of obligations to the Bureau of Reclamation within the Northport Irrigation District in the State of Nebraska.

• **H.R.** (Hastings of Washington), To modify the Forest Service Recreation Residence Program as the program applies to units of the National Forest System derived from the public domain by implementing a simple, equitable, and predictable procedure for determining cabin user fees, and for other purposes. *"Cabin Fee Act of 2014"*.
