- **H.R. 929 (Rep. Kilmer)**, “*Puyallup Tribe of Indians Land Into Trust Confirmation Act of 2023*”;
- **H.R. 934 (Rep. McClintock)**, To require the Secretary of Agriculture to carry out activities to suppress wildfires, and for other purposes. *(Amendments to H.R. 934 must be drafted to the amendment in the nature of a substitute, attached to this notice)*;
- **H.R. 1786 (Rep. Levin)**, “*Get Rewarding Outdoor Work for our Veterans Act*” or “*GROW Act*”;
- **H.R. 3448 (Rep. Stefanik)**, “*American Battlefield Protection Program Enhancement Act*”; *(Amendments to H.R. 3448 must be drafted to the amendment in the nature of a substitute, attached to this notice)*;
- **H.R. 4051 (Rep. Wittman)**, “*Supporting the Health of Aquatic systems through Research Knowledge and Enhanced Dialogue Act*” or “*SHARKED Act*” *(Amendments to H.R. 4051 must be drafted to the amendment in the nature of a substitute, attached to this notice)*; and
- **H.R. 4596 (Rep. Boebert)**, “*Upper Colorado and San Juan River Basins Endangered Fish Recovery Programs Reauthorization Act of 2023*”.
