Subject: Legislative Hearing – June 10, 2014

On **Tuesday, June 10, 2014 at 10:00 a.m. in room 1324 Longworth House Office Building**, the Subcommittee on Public Lands and Environmental Regulation will hold a legislative hearing on the following bills:

- **H.R. 318** (Hall), To authorize a Wall of Remembrance as part of the Korean War Veterans Memorial and to allow certain private contributions to fund that Wall of Remembrance.
- **H.R. 4029** (Smith of MO), To require the Secretary of the Interior to transfer all Federal land, facilities, and any other assets associated with the Ozark National Scenic Riverways to the State of Missouri for the purposes of maintaining a State park, and for other purposes.
- **H.R. 4049** (Duffy), To amend the Act to provide for the establishment of the Apostle Islands National Lakeshore in the State of Wisconsin, and for other purposes, to adjust the boundary of that National Lakeshore to include the lighthouse known as Ashland Harbor Breakwater Light, and for other purposes. *“Ashland Breakwater Light Transfer Act”*
- **H.R. 4182** (Smith of MO), To provide that the Ozark National Scenic Riverways shall be administered in accordance with the general management plan for that unit of the National Park System, and for other purposes.
- **H.R. 4272** (Walden), To stop implementation and enforcement of the Forest Service travel management rule and to require the Forest Service to incorporate the needs, uses, and input of affected communities before taking any travel management action affecting access to units of the National Forest System derived from the public domain, and for other purposes. *“Forest Access in Rural Communities Act”*
- **H.R. 4283** (Simpson), To amend the Wild and Scenic Rivers Act to authorize the Secretary of the Interior to maintain or replace certain facilities and structures for commercial recreation services at Smith Gulch in Idaho, and for other purposes.
- **H.R. 4489** (Cleaver), To designate memorials to the service of members of the United States Armed Forces in World War I, and for other purposes. *“World War I Memorial Act of 2014”*
