Since 2009, the NIC-managed Pre-Employment Screening Program has helped trucking companies and drivers access over 2.5 million driver records through an easy-to-use online service.

In addition to leading major eGovernment projects for a private sector provider, I have experience working for state government. I served as a project manager for the State of Rhode Island Division of Administration, where I was assigned to identify ways that technology could help constituents more easily navigate state government agencies and services.
