I direct AFRC's in-house and outside counsel in supporting the goal of sustainable timber harvest from public lands throughout the five states where our members operate. The legal program works to defend projects in court by intervening in litigation on behalf of member companies. We work to build positive precedent that supports active management and sustained timber harvest. Particularly in this era of climate change and unprecedented fires, active management is key to maintaining forest health as well as the stability of our rural communities. AFRC also strategically undertakes regulatory challenges when the government fails to live up to legal requirements.

In addition to AFRC and its membership, I have represented collaborative groups and local governments in support of needed forest management projects.
