TPWD is not a 501(c)(3) nonprofit, but a governmental entity.

However, within certain limits, charitable contributions to TPWD are deductible from individual and corporate federal income tax. 26 U.S.C. §170(a). The Internal Revenue Code defines "charitable contribution" to include "<u>a contribution or gift to or for the use of . . . a State</u>, a possession of the United States, or any political subdivision of any of the foregoing, or the United States or the District of Columbia, but only <u>if the contribution or gift is made for exclusively public purposes</u>." (Emphasis added.) 26 U.S.C. §170(c). Similarly, IRS Publication 526 states that contributions to a "qualified organization" are deductible and that a "qualified organization" includes the United States or a State, if the contribution is used for public purposes. Examples listed in Publication 526 include donations to a city policy department's information reward program, public parks and recreation programs.
