

What They Are Saying: H.R. 4776, The SPEED Act

WASHINGTON, D.C. - Recently, House Committee on Natural Resources Chairman Bruce Westerman (R-Ark.) and U.S. Rep. Jared Golden (D-Maine) introduced the bipartisan Standardizing Permitting and Expediting Economic Development (SPEED) Act. Organizations, officials and a wide variety of industry leaders from across the
