Resident Representative to the United States  
Commonwealth of the Northern Mariana Islands (CNMI)



Pedro (Pete) A. Tenorio was elected Resident Representative for the Commonwealth of the Northern Mariana Islands (CNMI) in November, 2001.

Representative Tenorio is dedicated to establishing an enduring friendship and a permanent political relationship between the CNMI and the United States, securing for the citizens of the CNMI a non-voting Delegate to Congress, diversifying and increasing the CNMI's economic and business activity, increasing and expanding access to federally funded health benefits, and improving and exploring new education and cultural exchange programs.

He is in the process of forming the Fund for Friends of the Commonwealth Political Action Committee.

Representative Tenorio has contributed over 25 years of public service to the people of the Commonwealth of the Northern Mariana Islands. Prior to coming to Washington, D.C., Representative Tenorio served two terms as Lieutenant Governor of the CNMI from 1981-1989. He served as Legislative Advisor for the 1<sup>st</sup> CNMI Legislature and as an Executive Director of the Marianas Public Land Corporation from 1977-1981. He served as the Executive Director of the U.S. funded Northern Marianas Office of Transition Studies and Planning from 1975-1977. As a member of the Northern Marianas Political Status Commission from 1973-1976, Tenorio was one of the key negotiators of the "Covenant to Establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America," (U.S. Public Law 94-241). He served as a Senator for the Northern Marianas in the Congress of Micronesia from 1972-1974.

Representative Tenorio is an active member of the Lion's Club of East Manoa, Honolulu, Hawaii. Born and raised in Saipan, Representative Tenorio holds a MS degree in Environmental Health and a MS degree in Hydrology from the University of Hawaii, where he also graduated with a BA in Geology.
