Dear Administrator Long:

On October 12, 2017, the Federal Bureau of Investigation (FBI) San Juan Field Office announced that "[t]he FBI has received numerous complaints of mishandling and misappropriation of emergency supplies provided by the federal government for the people of Puerto Rico, by local government officials." Specifically, the FBI is investigating the misappropriation of Federal Emergency Management Agency (FEMA) supplies in at least six of Puerto Rico's 78 municipalities.²

According to an FBI Special Agent in San Juan, the complaints include allegations that, "mayors of local municipalities, or people associated with their offices, are giving their political supporters special treatment, goods they're not giving to other people who need them." One allegation accuses a party official driving off in his personal vehicle full of FEMA supplies obtained from a government building.4 The Office of the United States Attorney for the District of Puerto Rico is also investigating these complaints.⁵

The Committee is very troubled by these allegations. Hurricane Maria struck Puerto Rico as the island's most devastating storm since 1928, and is estimated to have caused \$45 to \$95 billion in damage to the territory.⁶ In addition to the heart-rending loss of life, almost a month later, 85 percent of residents still do not have electricity and 40 percent do not have access to running water.⁷ The Federal Communications Commission reports that approximately 74

percent of the island's cellular sites are inoperable.⁸ It is estimated that it will take months for these vital services to be restored to the island.⁹ Meanwhile, approximately 350,000 Puerto Rican residents have registered with FEMA to receive financial assistance.¹⁰

Prior to Hurricane Maria's landfall, FEMA along with the Department of Defense prepositioned emergency response assets and supplies for quick activation. Thousands of emergency relief workers are deployed in Puerto Rico. To date, FEMA, in conjunction with other federal agencies, has provided more than 8 million meals and 6 million liters of water with millions more liters of water and meals expected to be distributed in the coming weeks. 13

With so many residents still in grave need of basic supplies, it is essential that assistance from the federal government is provided in the most efficient and effective manner possible. The public's confidence in the integrity of FEMA's distribution of emergency supplies is also imperative. Allegations that local elected officials are distributing life-sustaining FEMA emergency supplies based on political loyalty is deeply disturbing. Any persons misappropriating FEMA emergency supplies should be prosecuted to the fullest extent of the law.

Per House Rule X, the Committee on Natural Resources is the principal committee of jurisdiction for insular areas of the United States. Therefore, to assist the Committee's oversight of the recovery efforts in Puerto Rico, please provide a briefing to the Committee as soon as possible, but no later than 5:00 p.m. on October 23, 2017.
