Dear Ms. Dillen:

The House Committee on Natural Resources (Committee) is investigating Earthjustice's role in the Biden administration's cancellation of two decades-old mineral leases in the Superior National Forest (Twin Metals leases) and withdrawal of 225,504 acres of mineral-rich land in the same area from mineral exploration and development (Superior Withdrawal).<sup>1</sup> The Committee is particularly concerned with, at the very least, a serious appearance of impropriety—if not ethical violations—stemming from collusion among Earthjustice's clients The Wilderness Society (TWS), the Center for Biological Diversity (CBD), other activist environmental groups, and the Biden administration.<sup>2</sup>

In 2018, the federal government reinstated mineral leases for the prospective Twin Metals copper-nickel-cobalt mining project in Northeast Minnesota.<sup>3</sup> In December 2019, the company

developing Twin Metals formally submitted a Mine Plan of Operations to begin the federal permitting process; the Minnesota Department of Natural Resources also conducted its own environmental impact review.<sup>4</sup> In August 2020, various preservationist groups, including TWS and CBD, sued the Bureau of Land Management (BLM), U.S. Fish and Wildlife Service (FWS), and the Forest Service (USFS) in an effort to stop the Twin Metals leases.<sup>5</sup>

Amid ongoing litigation, in January 2022, the Biden administration canceled the Twin Metals leases.<sup>6</sup> The Biden administration's actions spurned years of environmental review; a pending Mine Plan of Operations;<sup>7</sup> and myriad comments and letters from Members of Congress, mineral developers, locals, union workers, and many other stakeholders overwhelmingly expressing support for the Twin Metals project. That same month, the Biden administration also finalized the Superior Withdrawal, totaling 225,504 mineral-rich acres to further kneecap America's ability to responsibly mine essential minerals domestically.<sup>8</sup> Subsequently, Earthjustice represented several environmental groups, including CBD and TWS, in their effort to intervene and defend the Biden administration's actions in Northern Minnesota in a lawsuit brought by Twin Metals.<sup>9</sup>

These Biden administration actions followed private, off-the-books meetings between high-ranking members of Biden's Department of the Interior (DOI) and at least one of the environmental groups suing the federal government over Twin Metals and later intervening to defend the Biden administration's lease cancellation.<sup>10</sup> These meetings reportedly included both environmental lobbyists and attorneys, focusing not only on the ongoing litigation but also on the policies and politics surrounding mining in Minnesota and Twin Metals.<sup>11</sup> At the very least, these

meetings created a serious appearance of impropriety; more likely, these meetings violated ethical standards and evidence potentially improper relationships between TWS, CBD, and other similarly radical groups, and the Biden administration.

Consequently, the Committee is keen to discover the details of Earthjustice's involvement in supporting TWS's and CBD's backroom roles in the cancellation of the Twin Metals leases and the Superior Withdrawal, particularly given tax-exempt environmental groups' continued pressure to oppose mining in Northern Minnesota and otherwise negatively influence America's natural resource and energy priorities.<sup>12</sup>

Accordingly, the Committee hereby requests that Earthjustice provide the following documents and information in your possession, custody, or control, in complete, unredacted, and electronic format, as soon as possible but no later than December 15, 2025:

1. All documents and communications among or between Earthjustice, TWS, CBD, DOI, BLM, FWS, or USFS related to the cancellation of the Twin Metals leases, from January 20, 2021, to January 19, 2025.
2. All documents and communications among or between Earthjustice, TWS, CBD, DOI, BLM, FWS, or USFS related to the Superior Withdrawal, from January 20, 2021, to January 19, 2025.
3. All documents and communications among or between Earthjustice, TWS, CBD, DOI, BLM, FWS, or USFS related to mining in Minnesota, from January 20, 2021, to January 19, 2025.
4. Documents and communications sufficient to show dates, attendees, agendas, and minutes of any meetings among or between Earthjustice, TWS, CBD, DOI, BLM, FWS, or USFS related to the cancellation of the Twin Metals leases, from January 20, 2021, to January 19, 2025.
5. Documents and communications sufficient to show dates, attendees, agendas, and minutes of any meetings among or between Earthjustice, TWS, CBD, DOI, BLM, FWS, or USFS related to the Superior Withdrawal, from January 20, 2021, to January 19, 2025.
6. Documents and communications sufficient to show all litigation costs—including but not limited to attorney's fees, hours, salaries, bonuses, filing fees, and other expenses—incurred by Earthjustice for which Earthjustice sought reimbursement.
