Since 1982, Mr. Albert S.N. Hee has been in the private utility business, leading to the founding of Waimana Enterprises in 1988. Waimana Enterprises is a holding company for several subsidiaries which are primarily engaged in developing investor owned utilities in Hawaii. Each subsidiary develops and/or owns and/or operates a utility system. Mr. Hee's primary role is to create the business opportunity for each of the subsidiaries.

Investor owned utilities have existed in Hawaii since well before the 1900's. They are an alternative to municipal owned utilities, which are funded through taxes. In a small state like Hawaii, competition for Mr. Hee's projects come from the well established monopoly utilities. Creation of utilities is capital intensive. Mr. Hee's success has been attributed to his creative solutions to financing projects each requiring hundreds of millions of dollars.

Waimana Enterprises (through its subsidiaries) developed the largest hydroelectric power plant in Hawaii and has several more power facilities in various stages of development. Currently, another Waimana subsidiary, Sandwich Isles Communications, is developing a state-wide telecommunications network. The state-wide telecommunications network will make it possible for native Hawaiians living on Hawaiian Home Lands to access the latest social, medical, educational, and commercial telecommunications services.

Prior to beginning his entrepreneurial career, Mr. Hee served in the U.S. Navy, after which he returned to Hawaii and worked for Theo H. Davies.

Mr. Hee, a native Hawaiian and Hawaiian Home Lands beneficiary, is a graduate of the Kamehameha Schools and the U.S. Naval Academy.
