AMENDMENT OF ARTICLES OF INCORPORATION
OF
FRIENDS OF THE BOUNDARY WATERS WILDERNESS*

Pursuant to Minnesota Statutes Chapter 317A, the following amendment to the corporation's Articles of Incorporation has been properly approved by the Board of Directors (there being no voting members of the corporation):

Strike existing Articles III and IV in entirety and replace with:

ARTICLE III
PURPOSE

This corporation is organized exclusively for charitable, scientific, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), as now enacted or hereafter amended. To this end, the corporation shall protect, preserve, and restore the wilderness character of the Boundary Waters Canoe Area Wilderness and the Quetico-Superior ecosystem. The corporation shall accomplish its mission by direct activities as well as by the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. ✓

All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV
LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended (hereinafter, "the Code"), nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually

tendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public (except as otherwise provided in subsection (1) of Section 501 of the Code), and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office;

3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code; and

4. The corporation shall not lend any of its assets to any officer or director of this corporation or guarantee to any person the payment of a loan by an officer or director of this corporation.

The undersigned officer certifies both that s/he executes this Amendment for the purposes herein stated, and that by such execution, affirms the understanding that should the information in this Amendment be intentionally or knowingly misstated, s/he is subject to the penalties for perjury set forth in Minnesota Statutes section 602.48 as if this document had been executed under oath.


