#### Jonathan C. Kaledin Professional Biography

Jonathan Kaledin is the Executive Vice President/General Counsel of Natural Systems Utilities (NSU), based in Hillsborough, New Jersey. NSU, one of the U.S.'s leading green infrastructure companies, develops the next generation of U.S. water and energy infrastructure—water reuse, anaerobic digestion, thermal energy recovery, and technologically differentiated energy, water, and wastewater projects.

Prior to joining NSU full-time (previously one of his clients), Jon ran 11<sup>th</sup> Avenue Strategies, a consultancy specializing in water, environmental policy, energy efficiency, and land conservation work issues. His clients included the Stockholm International Water Institute (SIWI), the Growing Blue Collaborative (GBC), the Rauch Foundation, the Global Buildings Performance Network (GBPN), and others. For SIWI, Jon acted as U.S. representative, undertaking program and project development work, strategic planning, and fundraising in North and Latin America. For the GBC, a private-public consortium working to highlight the nexus between water and the economy, Jon acted as the initial Secretariat, with overall management and administrative responsibility for the GBC. GBC members included the World Resources Institute, UN CEO Water Mandate, IBM, GE, Xylem, Veolia, World Wildlife Fund, The Nature Conservancy, WBCSD, and others. In 2013, the U.S. State Department invited Jon to act as a U.S. representative at the first Water Week Latin America, meeting with Chilean government officials, academics, and others to discuss and evaluate Chilean water policy and governance issues. In 2014, Jon led the Paris-based GBPN, one of the world's leading buildings energy efficiency knowledge sharing platforms, through strategic planning work on fund-raising and organizational structure.

Jon's career in the environmental field now spans thirty years. His fifteen year tenure with The Nature Conservancy (TNC) included involvement in and oversight of some of the most complex water policy and land conservation transactions in the U.S., including overseeing the creation of the first private marine sanctuary established in the U.S. (the Bluepoints Preserve), and including work as TNC's global counsel on water and marine issues. From 2008 through 2010, and as part of his responsibilities as director of TNC's global water stewardship program, Jonathan acted as the Secretariat for the Alliance for Water Stewardship, directing and overseeing the international collaborative designing and developing the world's first water certification program, one of the most important international water policy efforts of the recent past.

From 1991 through 1995, and after working for the U.S. Environmental Protection Agency, where he focused on Clean Water Act, Safe Drinking Water Act, and National Environmental Policy Act matters, Jon ran the National Water Education/Funding Council (NWE/FC). The NWE/FC project developed policy and proposals for addressing the funding of U.S. water infrastructure, and advocated successfully for the establishment of the federal/state revolving fund program for the SDWA. In addition to the positions mentioned above, Jon served as General Counsel of Environmental Affairs for the Commonwealth of Massachusetts for Governor Mitt Romney, and has practiced law in the private sector.

He has given guest lectures at many universities and colleges, including at the Harvard Business School, Northeastern School of Law, Albany Law School, and others, and speaks frequently on water and other environmental issues, including in recent years at the inaugural Imagine Solutions conference (where Jon spoke on "The World of Water" and preceded Sylvia Earle speaking on oceans), Stockholm's World Water Week, Brisbane's International River Symposium, Seoul's B4E Global Summit, and at Singapore's International Water Week. In 2015, Jon co-edited and wrote a chapter for the textbook "Water and Latin American Cities: Challenges for Sustainable Development" (Earthscan/Routledge), and his articles on water and environmental issues have appeared in numerous journals and newspapers, including The American Prospect, Wall Street Journal, Boston Globe, and others. He has been on the board of directors of any number of private and public sector entities--the U.S. Water Alliance, NY League of Conservation Voters-Capital District, Ausable Press, Pierian Foundation--and currently sits on the board of the Princeton Symphony Orchestra and on the strategic advisory council of New World Capital, where he advises the company on water issues.

Jon received his B.A. from Harvard (*magna cum laude* in Music) and his J.D. from New York University. While at NYU Law School, wrote the 1983 article on environmental law for the Annual Review of American Law, and was President of the Environmental Law Society. A professionally trained cellist, Jon has an extensive life in the arts as well.
