

Property was purchased at a Sheriff's Sale, in McIntosh County, at the price of \$2,000,000. The remaining property in question is "Corps of Engineer Land". This property is very vital because of a building built on property line.

The Corps of Engineer has agreed to sell or transfer this property to the Muscogee (Creek) Nation and is fully supportive of legislation for the sale or transfer of the property to the Muscogee (Creek) Nation. The Nation is currently operating the 18-hole golf course which is connected to the adjacent property.

As Principal Chief, I depend on my support staff, namely Mike Flud, Chief of Staff. I assigned Mr. Mike Flud full control over this project; he has done a great job. Therefore, my knowledge of this project is limited.

The Muscogee (Creek) Nation bought the property known as Fountainhead Resort located in Eufaula, Oklahoma, at a Sheriff's Sale in August, 2005 for two million dollars. The Nation was the only bidder. The resort property consisted of 48+ acres, a 188 room 5-story hotel, a 27,000+ sq. ft. recreation buildings, and some duplex cabins. The property also came with an 18+ acre Corps of Engineers lease which also included some duplex cabins.

It was determined from the official survey that the recreation building sat entirely on Corps land and the survey line split one of the duplexes. When we approached the Corps about buying the property that our building sat on the Corps offered to sell the entire 18+ acres to the Nation and offered to help write the legislation.

It has been the Nation's intention since the purchase to make the property a family destination resort on Lake Eufaula with a casino, restaurant, children area and hotel. To that end we have razed the hotel and now have security living on the property. We have also secured resolutions of support from the surrounding cities, chamber of commerce, lake associations and area state representatives. The Nation also leased the 18-hole Fountainhead Golf Course from the Corps and our legislative body, known as our National Council, has appropriated more than \$2 million to renovate the course. The State of Oklahoma had the lease and was in the process of closing the course because of economics. The course abuts the Fountainhead property.

We have just very recently started the preliminary paperwork to put the property into trust and there are several reasons for this delay. 1.) We know that all of the property will have to be put into trust for gaming. 2.) We were waiting on Congressional action so that if we are successful we will be able to move closer to the lake shore to build. 3.) We began the building of our \$200 million facility at our Tulsa location along the Arkansas River in 2007 and completed the project in 2009 so our priorities changed during this period.

I suppose the existing recreation building could be used as a casino but as I have mentioned above we promised the people in the area that Fountainhead would be a family destination resort and it would be much more feasible to use that building as an entertainment area for the kids.

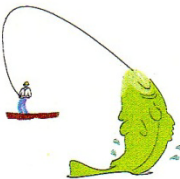




