(D) WIND LEASE SALE OFF COAST OF AMERICAN SAMOA.—If the study required under paragraph (1)(A) concludes that a wind lease sale on the outer Continental Shelf off the coast of American Samoa is feasible, then the Secretary shall offer a wind lease sale on the outer Continental Shelf off the coast of American Samoa as soon as practicable, but not later than one year after the date of the enactment of this section.

(E) WIND LEASE SALE OFF COAST OF THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS.—If the study required under paragraph (1)(A) concludes that a wind lease sale on the outer Continental Shelf off the coast of the Commonwealth of the Northern Mariana Islands is feasible, then the Secretary shall offer a wind lease sale on the outer Continental Shelf off the

coast of the Commonwealth of the Northern Mariana Islands as soon as practicable, but not later than one year after the date of the enactment of this section.

Page 42, line 21, insert “annual” after “nonrefundable”.
