**A BILL**

To reauthorize the Federal Land Transaction Facilitation Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Land Trans-  
5 action Facilitation Act Reauthorization of 2018”.

6 **SEC. 2. FEDERAL LAND TRANSACTION FACILITATION ACT.**

7 The Federal Land Transaction Facilitation Act is  
8 amended—

1 (1) in section 203(1) (43 U.S.C. 2302(1)), by  
2 striking “cultural, or” and inserting “cultural, rec-  
3 reational access and use, or other”;

4 (2) in section 203(2) (43 U.S.C. 2302(2))—

5 (A) in the matter preceding subparagraph  
6 (A), by striking “on the date of enactment of  
7 this Act was” and inserting “is”;

8 (B) by striking “area, or” and inserting  
9 “area,”;

10 (C) by inserting after “natural area,” the  
11 following: “priority species and habitats des-  
12 ignated in a land use plan in accordance with  
13 subpart E (entitled ‘Fish and Wildlife’) of part  
14 I of Appendix C of Bureau of Land Manage-  
15 ment Land Use Planning Handbook H-1601-  
16 1 (Rel 1-1693), or a special recreation manage-  
17 ment area,”; and

18 (D) by amending subparagraph (D) to  
19 read as follows:

20 “(D) a National Forest or National Grass-  
21 land in the National Forest System;”;

22 (3) in section 205 (43 U.S.C. 2304)—

23 (A) in subsection (a), by striking “section  
24 206” and all that follows through the period  
25 and inserting the following: “section 206—

1 “(1) to complete appraisals and satisfy other  
2 legal requirements for the sale or exchange of public  
3 land identified for disposal under approved land use  
4 plans under section 202 of the Federal Land Policy  
5 and Management Act of 1976 (43 U.S.C. 1712);

6 “(2) not later than 180 days after the date of  
7 the enactment of the Federal Land Transaction Fa-  
8 cilitation Act Reauthorization of 2018, to establish  
9 and make available to the public, on the website of  
10 the Department of the Interior, a database con-  
11 taining a comprehensive list of all the land referred  
12 to in paragraph (1); and

13 “(3) to maintain the database referred to in  
14 paragraph (2).”; and

15 (B) by striking subsection (d);

16 (4) in section 206(c)(2) (43 U.S.C. 2305(c)(2)),  
17 by adding at the end the following:

18 “(E) Any funds made available under sub-  
19 paragraph (D) that are not obligated or ex-  
20 pended by the end of the fourth full fiscal year  
21 after the date of the sale or exchange of land  
22 that generated the funds may be expended in  
23 any State.”;

24 (5) in section 206(c)(3) (43 U.S.C.  
25 2305(c)(3))—

1 (A) by inserting after subparagraph (A)  
2 the following:

3 “(B) the extent to which the acquisition of  
4 the land or interest therein will increase the  
5 public availability of resources for, and facilitate  
6 public access to, hunting, fishing, and other rec-  
7 reational activities;” and

8 (B) by redesignating subparagraphs (B),  
9 (C), and (D) as subparagraphs (C), (D), and  
10 (E);

11 (6) by striking section 206(f) (43 U.S.C.  
12 2305(f)); and

13 (7) in section 207(b) (43 U.S.C. 2306(b))—

14 (A) in paragraph (1)—

15 (i) by striking “96–568” and insert-  
16 ing “96–586”; and

17 (ii) by striking “; or” and inserting a  
18 semicolon;

19 (B) in paragraph (2)—

20 (i) by inserting “Public Law 105–  
21 263;” before “112 Stat.”; and

22 (ii) by striking the period at the end  
23 and inserting a semicolon; and

24 (C) by adding at the end the following:

1           “(3) the White Pine County Conservation,  
2       Recreation, and Development Act of 2006 (Public  
3       Law 109–432; 120 Stat. 3028);

4           “(4) the Lincoln County Conservation, Recre-  
5       ation, and Development Act of 2004 (Public Law  
6       108–424; 118 Stat. 2403);

7           “(5) subtitle F of title I of the Omnibus Public  
8       Land Management Act of 2009 (16 U.S.C. 1132  
9       note; Public Law 111–11);

10          “(6) subtitle O of title I of the Omnibus Public  
11       Land Management Act of 2009 (16 U.S.C. 460www  
12       note, 1132 note; Public Law 111–11);

13          “(7) section 2601 of the Omnibus Public Land  
14       Management Act of 2009 (Public Law 111–11; 123  
15       Stat. 1108); or

16          “(8) section 2606 of the Omnibus Public Land  
17       Management Act of 2009 (Public Law 111–11; 123  
18       Stat. 1121).”.
