## Summary of the Bill

H.R. 3607, introduced by Congressman Tom McClintock (R-CA-4), authorizes the Secretary of the Interior to establish and collect fees for medical services provided to persons in units of the National Park System. Fees collected, as well as any donations, are to be deposited into a special account at the Treasury and, to the extent provided by advance appropriations, will be made available to the Secretary for a variety of uses related to the provision of medical services.

## Background

The National Park Service (NPS) currently manages eleven units that provide medical services, including ambulance transport, EMT services, and clinical services. These units are remote and visitors and staff have few or no other options for receiving timely medical care, especially in emergency situations.

Under current law, the NPS has the authority and responsibility to provide medical services, but does not have authority to retain revenues from insurance payments or other payments, which go to the general Treasury. The NPS does not collect fees directly but instead works with third-party agencies to bill insurance companies or individuals. The ability to retain revenues to offset the costs of medical services would help the NPS to provide higher quality patient care with industry standard equipment and technology.

The following tables provided by the NPS to staff show the amounts that were collected for medical services and the amounts allocated to run medical services at each of the eleven units in FY 2016:

### **Major Provisions**

- Authorizes the Secretary of the Interior to establish and collect fees for medical services provided to persons in units of the National Park System.
- Establishes a “National Park Medical Services Fund” at the Treasury, consisting of donations to the fund and fees collected by the Secretary.
- Allows for amounts deposited into the fund to be made available to the Secretary, subject to advance appropriation, for the following uses:

1. Providing medical services to persons in NPS units.
2. Preparing needs assessments or other programmatic analyses for medical facilities, equipment, vehicles, and other needs and costs of providing medical services.
3. Developing management plans for medical facilities, equipment, vehicles, and other needs and costs of medical services.
4. Training related to providing medical services.
5. Obtaining or improving medical facilities, equipment, vehicles, and other needs and costs of providing medical services.

### **Administration Position**

On October 11, 2017, Bob Vogel, Acting Deputy Director for Operations, National Park Service, offered a statement on H.R. 3607 at a Subcommittee on Federal Lands legislative hearing. The statement recommended the following: 1) the bill be amended to authorize the retention of medical services receipts as cost recovery instead of establishing and administering a separate fund at the Treasury; 2) the bill allow for the expenditure of medical services receipts without further appropriation; and 3) the bill ensure that the NPS can collect fees for medical services provided by personnel outside of units of the National Park System.

### **Anticipated Amendments**

- Chairman McClintock will offer an amendment to authorize the NPS to also collect fees for medical services provided by personnel outside of units of the National Park System.

### **Effect on Current Law (Ramseyer)**

This bill does not affect current law.
