A BILL

To provide for the transfer of certain public land currently administered by the Bureau of Land Management to the administrative jurisdiction of the Secretary of the Navy for inclusion in Naval Air Weapons Station China Lake, California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Naval Air Weapons
5 Station China Lake Security Enhancement Act”.

1 **SEC. 2. TRANSFER OF ADMINISTRATIVE JURISDICTION,**
2 **NAVAL AIR WEAPONS STATION CHINA LAKE,**
3 **CALIFORNIA.**

4 (a) **TRANSFER REQUIRED.**—Not later than Sep-
5 tember 30, 2014, the Secretary of the Interior shall trans-
6 fer to the administrative jurisdiction of the Secretary of
7 the Navy certain public land administered by the Bureau
8 of Land Management in Inyo, Kern, and San Bernardino
9 Counties, California, consisting of approximately
10 1,030,000 acres in Inyo, Kern, and San Bernardino Coun-
11 ties, California, as generally depicted on the map titled
12 “Naval Air Weapons Station China Lake Withdrawal -
13 Renewal” and dated 2012.

14 (b) **USE OF TRANSFERRED LAND.**—Upon the receipt
15 of the land under subsection (a), the Secretary of the Navy
16 shall include the land as part of the Naval Air Weapons
17 Station China Lake, California, and authorize use of the
18 land for military purposes.

19 (c) **LEGAL DESCRIPTION.**—

20 (1) **PREPARATION AND PUBLICATION.**—The
21 Secretary of the Interior shall publish in the Federal
22 Register a legal description of the public land to be
23 transferred under subsection (a).

24 (2) **FORCE OF LAW.**—The legal description filed
25 under paragraph (1) shall have the same force and
26 effect as if included in this Act, except that the Sec-

1 retary of the Interior may correct errors in the legal
2 description.

3 (d) REIMBURSEMENT OF COSTS.—The transfer re-
4 quired by subsection (a) shall be made without reimburse-
5 ment, except that the Secretary of the Navy shall reim-
6 burse the Secretary of the Interior for any costs incurred
7 by the Secretary of the Interior to prepare the legal de-
8 scription under subsection (c).
