Page 3, after line 4, add the following (and redesignate the subsequent paragraphs accordingly):

- 1 (2) By striking "during those months when 2 there is no other discharge therefrom, but this re-3 lease may be reduced for brief temporary periods by 4 the Secretary whenever he may find that release of 5 the full ten cubic feet per second is harmful to the 6 primary purpose of the project".
- Page 3, strike lines 5 through 24, and insert the following:
- 7 (3) By adding at the end the following: "With8 out further action by the Secretary, and as deter9 mined necessary for any given year by the City of
 10 Prineville, up to seven of the 17 cubic feet per sec11 ond minimum release shall also serve as mitigation
 12 for City of Prineville groundwater pumping, pursu-

· i	ant to and in a manner consistent with Oregon State
2	law, including any shaping of the release of the up

Page 4, line 15, strike "2011." and insert "2011, and up to 2,740 acre feet of water annually to supply the McKay Creek lands as provided for in section 5 of this Act.".

Page 5, line 6, strike "modify" and insert "modifies".

Page 7, line 2, insert "up to" after "supplying".

Page 7, line 4, strike "under paragraph (2)." and insert "and classified as irrigable under paragraphs (2) and (3), with such stored water to be supplied on an acre-per-acre basis contingent on the transfer of existing appurtenant McKay Creek water rights to instream use and the State's issuance of water rights for the use of stored water.".

In section 5(d), strike "District" each place it appears and insert "district".
