Bio for Gordon Myers

Gordon Myers was appointed to his current position of executive director of the North Carolina Wildlife Resources Commission in August 2008. The Commission's mission is to conserve North Carolina's wildlife resources and their habitats and provide programs and opportunities that allow hunters, anglers, boaters and other outdoor enthusiasts to enjoy wildlife associated recreation. In the 17 years prior to his appointment in August 2008, Gordon worked for the Commission in varying capacities. His work experience includes engineering design and construction of public boating access areas, fishing piers, and other agency infrastructure. He was charged with the initial development and administration of the Commission's Engineering Services Division where he oversaw the agency's capital development program which included major overhauls to the agency's fish production infrastructure and development of the first sustainably designed state government office building in North Carolina. More recently prior to his appointment, Gordon was responsible for identifying opportunities to improve agency efficiency and organizational effectiveness and implementation of agency legislative relations strategies. He is a 1990 graduate of N.C. State University's Department of Civil Engineering.


